



GK8 Bounty Campaign Program Terms and Conditions

The GK8 Bounty Campaign Terms and Conditions (the “**Terms**”) govern your participation in the GK8 Bounty Campaign (the “**Campaign**”). These terms are between you and GK8 Ltd., a company incorporated under the laws of Israel (“**GK8**”). By participating in the Campaign in any manner, you agree to these Terms. GK8 retains the right to assert that any attempts at computer penetration or hacking, or any access or retention of the Bounty (as defined below) made in violation or not in compliance with these Terms are unlawful.

Campaign Summary

The Campaign permits you to attempt to penetrate GK8’s digital asset security technology during the Campaign period of February 3, 2020 at 9:00 AM EST to February 4, 2020 at 9:00 AM EST, provided that you submit any discovered vulnerabilities and hacking techniques used in the context of the Campaign (the “**Techniques**”) to GK8. An individual participant will be eligible to take legal ownership of the contents in the amount of up to 14 bitcoins (the “**Bounty**”) of a specifically earmarked secure digital asset (the “**Campaign Wallet**”) upon (i) being the first individual to successfully penetrate the Campaign Wallet and transferring to itself all of its content (the “**First Successful Penetration**”) and (ii) submitting in full written detail the Techniques used to penetrate said Campaign Wallet (the “**Submittal**”) and (iii) being in full compliance with these Terms. The Submittal must include a full description of all the software, hardware and techniques used and a step by step description of the penetration plan, all subject and in accordance with the Terms. In addition, following the submission of the Submittal by the individual performing the First Successful Penetration, and subject to the inclusion in such Submittal of all the required information to the full satisfaction of GK8 as determined in its sole discretion, GK8 will provide the individual performing the First Successful Penetration with an additional prize in its own discretion. Such additional prize shall be in the amount of up to 14 bitcoins and in no event larger than the Bounty. GK8 may terminate the Campaign at any time without notice. Following termination of the Campaign, all attempts at penetration must cease and, if no First Successful Penetration has occurred prior to termination, then no participant shall be eligible to take legal ownership of the Bounty.

Changes to these Terms

GK8 reserves the right to change these Terms at any time. These Terms are the sole and exclusive terms in connection with the Campaign and no other terms shall govern any part of the Campaign.

Campaign Eligibility

You must meet *all* of the following requirements in order to be eligible to participate in the Campaign:

- You are an individual of 18 years of age or older.
- If you serve as an employee, contractor, or freelancer of an organization, your organization permits you to participate in the Campaign. You are responsible for reviewing your organization’s rules for participation in the Campaign.

You are *not* eligible to participate in the Campaign if any of the following criteria apply to you:

- You are under 18 years of age.



- You, or an immediate family or household member, are an employee or a consultant of GK8 Ltd.
- You were an employee or a consultant of GK8 in the twelve months prior to your participation in the Campaign.
- Your employer or organization does not allow you to participate in the Campaign.
- You are engaged by or serve in any governmental security services, including without limitation, the Israeli Defense Forces, the Israeli Security Agency (Shin Bet), the Mossad, the FBI, the CIA, or any similar agency.
- You are not, owned or controlled by, or identified with, any person, entity or organization included on any applicable list of persons or entities sanctioned (including economic or financial sanctions, trade embargoes and export control restrictions) by an international, national or regional government or authority, whether specifically or by reference, and are not located in, or affiliated with the governments of, any country subject to broad or comprehensive sanctions.
- You are not allowed to participate in the Campaign under applicable law.

GK8 assumes no liability or responsibility for disputes arising between an employer and employee related to this Campaign.

Submission Process

Within 48 hours of successfully penetrating the Campaign Wallet and taking the Campaign Wallet's contents, the participant performing the First Successful Penetration must submit a complete Submittal. Failure to submit a complete report will lead to GK8 refusing to transfer legal ownership rights of the Campaign Wallet contents to the participant. A Submittal will only be considered complete upon GK8's written approval to the participant, to be provided within 30 days of receiving a Submittal. If GK8 does not transfer legal ownership of the Bounty to you within such 30 day period, you must return the Bounty to GK8. Participant agrees to answer any follow-up questions GK8 asks and understands that his/her Submittal may not be considered complete until all of GK8's questions are answered. GK8 retains sole discretion in determining whether a Submittal is detailed enough to earn the Bounty.

Submittal

You hereby irrevocably transfer and assign all rights, titles, interests and licenses to the intellectual property in your Submittal to GK8. You shall, upon GK8's request, execute all documents and take all steps necessary to effectuate the foregoing assignment to GK8 or its designee.

Confidentiality of Submittals

You hereby agree not to disclose the contents of your Submittal to any third party without the explicit permission of GK8. You further agree not to disclose to any third party your successful penetration of the Campaign Wallet secret, should you succeed.

Bounty

If you are unable or unwilling to accept the Bounty yourself, GK8 reserves the right to rescind it. You are responsible for any applicable taxes or government related to accepting the Bounty. You will indemnify GK8 in respect of any taxes or government charges imposed on GK8 as a result of the Bounty.



Code of Conduct

By participating in the Campaign, you will follow these rules:

- Do not do anything illegal
- Do not infringe upon the rights of others
- Do not engage in activity that is false or misleading
- Do not help others break these rules

Limitation of Liability

GK8 makes no warranties, express or implied, guarantees or conditions with respect to the Campaign. You understand that your participation in the Campaign is at your own risk. GK8 has no obligation or liability under this Campaign except to allow a successful participant that performed the First Successful Penetration to retain the specific Bounty made available by GK8 in such Campaign Wallet and obtained by such participant under the Terms of this Campaign.

Dispute Resolution

Any dispute under these Terms will be governed by the laws of the State of Israel, with exclusive jurisdiction to the competent courts of Tel Aviv-Jaffa. Notwithstanding the foregoing, either party may seek an interim injunction or other interim relief in any court of competent jurisdiction.
